JOSEPHINE MARTIN AWARD OF EXCELLENCE FOR SUPERVISORS, COORDINATORS, SPECIALISTS, AND STATE STAFF

The recipient of this award will be selected on the basis of innovations implemented in the following six (6) areas:

1. Program Enhancement

Georgia School Nutrition professionals manage nutritionally sound and cost effective programs. The nominee meets this criterion as described in the area of: *Program Enhancement*.

2. Staff Development

Georgia School Nutrition professionals promote lifelong learning for all members of the school nutrition team through staff development that strengthens leadership, practice, and enhances program outcomes. The nominee meets this criterion as described in the area of: **Staff Development**.

3. School Involvement

Georgia School Nutrition professionals promote the school nutrition program as an integral part of the total education program. The nominee meets this criterion as described in the area of: **School Involvement**.

4. Association Involvement and Promotion

Georgia School Nutrition professionals promote professional performance and practice in school nutrition programs through active membership in GSNA and SNA and through certification. The nominee meets this criterion as described in the area: **Association Involvement and Promotion**.

5. Community Involvement

Georgia School Nutrition professionals are actively involved in community organizations and alliances through networking and collaboration. The nominee meets this criterion as described in the area of: *Community Involvement*.

6. Public Policy

Georgia School Nutrition professionals advocate national, state, and local policy that supports healthful school meals and nutrition education for all children. The nominee meets this criterion as described in the area of: **Public Policy.**

Eligibility for Josephine Martin Award of Excellence

The Josephine Martin Award of Excellence recognizes a school nutrition leader at either the state level or a local school district program administrator for their outstanding contributions in the management of cost-effective school nutrition programs that provide healthy and appealing meals to students and help them develop healthy food habits. The program administrator position is anyone other than the Director and includes Manager/Supervisors, Coordinators, Specialist and Area Managers. School Nutrition Directors are not eligible as of 2015-2016.

Qualifications

To qualify the nominee/applicant must:

- 1. Be currently employed in the State Department of Education or in a Georgia school system as a Manager/Supervisor, Coordinator, Specialist or Area Manager in the School Nutrition Program.
- 2. Have been an active member of <u>SNA</u> and <u>GSNA</u>, and have provided leadership and support for District or Local chapter(s) for a minimum of Five (5) years.
- 3. Have served in at least one position on the state or national executive board or on an SNA national committee or on a state committee.
- 4. Be involved in their community through networking and alliances to share knowledge and expertise.
- 5. Be currently SNA certified or credentialed (membership and certification will be verified in the GSNA office.) **Judges**
